<b>Hazard Information:</b>	Primary Routes of Exposure: Dust inhalation, skin contact.
<b>Inhalation:</b>	Low acute inhalation toxicity. As with exposure to high concentrations of any dust, minimal irritation of the respiratory tract may occur. Exposure not probable with intended use.
<b>Skin Contact:</b>	Not an irritant. Low dermal toxicity. Not a dermal sensitizer.
<b>Eye Contact:</b>	Toner may act as a mechanical irritant.
<b>Ingestion:</b>	Low acute oral toxicity. Exposure not probable with intended use.

<b>Inhalation:</b>	If symptoms, such as shortness of breath or persistent coughing are experienced, remove source of contamination and move individual to fresh air. If symptoms persist, seek medical attention.
<b>Skin Contact:</b>	Wash with soap and water. Should irritation occur, seek medical attention.

**Eye Contact:** Do not rub eyes. Flush immediately with plenty of water. Remove contact lenses and continue flushing for at least 15 minutes. If irritation develops and persists, seek medical attention.

**Ingestion:** Do not induce vomiting. Slowly dilute with 1-2 glasses of water or milk and seek medical attention. Never give anything by mouth to an unconscious person.

Minimize dust generation during clean up. Sweep up spill with non-metallic broom and dustpan. Contain for disposal. Oil permeated sweeping compound may be useful in cleaning up spills.

This classification is based on rat "lung particulate overload" studies performed with airborne particulate carbon black. Toner is not listed by IARC, NTP, or OSHA.

**Aggravated Conditions:** Exposure to high airborne dust concentrations, including toner, may aggravate existing respiratory conditions.

**Carcinogenicity Comment:** Neither this product nor any of its components present above 0.1% are listed by IARC, NTP, or OSHA as known carcinogens.
